#### 27/15 Matters arising

##### 27.1 Texair Service Contract

Mike Lewis reported to the Committee that the meeting with Andy Houston of Texair had gone very well, that changes to the contract had been well received and that after clarification the fees would work out far less than the Committee had first understood. The new contract was now signed, with copies held at the BPA office and with Texair. **Completed**

##### 27.2 Judges laptop purchase

2 quotes, with specifications, had been provided by Computerlink and circulated to the Committee. After due discussion Mike Lewis proposed that 2 laptops be purchased as quoted in Option 2, quoted at £1443.72 per unit. Seconded by Jason

Kelleher.

**Carried unanimously**

[Secretary's note: Before Council of that evening Mike Lewis, on further discussion with Gavin McLeod that the specifications in Option 1 would be better suited for judges as will be viewing HiDef competition videos, that proposal is amended to Option 1, quoted at £1803.72 per unit. By email the Committee agreed]

The Judges Coordinator would store the laptops and distribute as required to the various competitions. Clarification regarding equipment insurance coverage would be sought from Romero Sports & Leisure.

**28/15 1<sup>st</sup> FAI World Cup in Wingsuit Performance Flying, 25-29 May, Netheravon,**

**Wiltshire** – taken out of agenda order as the COO was due to attend another meeting based at the BPA offices.

**28.1 Head of Delegation report**

John Hitchen, as Head of Delegation, and the Wingsuit Discipline rep, via their reports to Committee circulated before the meeting, stated that it had been a successful, well organised event. The Committee congratulated Jackie Harper, Mark Bayada, and their DZ teams on their organisation and running of the meet, given the challenges that the weather had presented at times. 57 competitors from 19 countries had attended and the Committee extolled Spike Harper on his Silver medal and those that had set new World records. **28.2 Matters arising**

The Committee were made aware that there were some concerns leading up to and during the event and in order for the Committee to understand these in more detail, Mike Lewis proposed a meeting with the Chair of APA, Chair of Council and himself as representative of the Competitions Committee at a mutually agreeable date and time. Seconded by Jason Kelleher. The Chair of Council would be requested to invite the APA Chair.

**Carried unanimously**

Jason Kelleher proposed, and was seconded by Gavin McLeod, that the office write to the delegation members as the Committee would value their perspective of events.

**Action: BPA Office**

**28.3 Competitor contract**

The consensus of the meeting was that the competitor contract required updating. Mike Lewis asked that this be discussed as an item on the August Competitions Committee meeting agenda.

**28.4 Wingsuit trainee judges course**

John Smyth reported on feedback received by him, that the course ran by Kate Charters had been superb. The Committee congratulated Kate, and Frank Mallabone on achieving FAI Wingsuit Judge status.

**29/15 Domestic Competitions 2015 – completed**

**29.1 Grand Prix CP Meet 1, Skydive UK, 24-26 Apr**

The Judges Coordinator reported that it was a good competition with brilliant weather, and was a beneficial training weekend for the Judges.

**29.2 Grand Prix CF Meet 1, BPS Langar, 9-10 May**

The weekend had been very successful and the DZ and judges had been excellent in their capacities. 1 senior team had not made the event due to a misprint in the magazine.

**29.3 Date Clashes**

The Judges Coordinator stated that there had been a number of date clashes this year and at times had struggled to provide judging team cover and would continue to as further in the year there are 4 competitions over 1 weekend. It was recommended that for next year that the dates are checked as the bids are received and that there is better liaison is required between the Discipline Reps and Judges Coordinator when arranging competitions and roadshows.

**29.4 Grand Prix VFS 2-way Meet 1, Target Skysports, 16-17 May**

The Artistics & VFS Discipline Rep, via email circulated to the Committee commented that 3 teams had registered but due to poor weather the competition had not taken place.

**29.5 BPA Open Nationals – Accuracy, Skydive Swansea, 22-24 May**

The Judges Coordinator reported that it had been a brilliant weekend with 23 competitors, including IPC President Graeme Windsor who had competed in the Open category. The Committee congratulated Carl Williams on his comeback to Accuracy and placing 1<sup>st</sup>. Comment had been made that the inflatable tuffet had caused some competitors to bounce. This had been discussed with Texair, who had provided the judging equipment.

**29.6 UKSL Meet 1, BPS Langar, 23-24 May**

Jason Kelleher reported that it was a good competition with challenging weather. All rounds had been completed except Round 6 of the Rookie category. There was 1 question regarding a camera malfunction and whether the team should have been allowed a re-jump. The Judges Coordinator reiterated that a cameraperson, including a 'Pool' cameraperson was included in the team and the consensus of the meeting was that re-jumps because of cameraperson error and camera failure would be at the discretion of the Chief Judge.

**29.7 Grand Prix CP Meet 2, Skydive UK, 12-14 June**

Kate Charters reported that all rounds had been completed for 10 competitors. A query arose with regard to yellow-carded competitor. The Judges Coordinator reassured the Committee that the competitor would be monitored during training jumps and throughout following CP meets; and that he would be red-carded should there be any serious breach of safety.

**30/15 Domestic Competitions 2015 – to be completed**

**30.1 BPA Open Nationals in Wingsuit – Rules**

The draft rules, as completed by the Wingsuit Discipline Rep, had been circulated to the Judges Coordinator. She informed the Committee that the rules were correct and needed no further amendment. **Approved**

**31/15 International Competitions 2015**

**31.1 8<sup>th</sup> FAI European & 5<sup>th</sup> FAI Junior Freefall Style & Accuracy Championships, 22-29 Aug, Erdan, Bulgaria**

Ian Marshall reported that there had been no interest.

[Secretary's note: The Preliminary registration had been returned on 19/6/15 as some had subsequently communicated their interest to attend on 18/6/15]

**31.2 8<sup>th</sup> FAI World Cup of Canopy Piloting, 23-29 Aug, Farnham, Canada**

7 delegation members had been registered – Brian Vacher, Maxine Tate, Martin Reynolds, Max Bruffell, Wez Westley, Alexis McNaughton and Henry Van Halewyn. The Committee Secretary would follow up on those who had not yet responded.

**Action: Committee Secretary**

**31.3 20<sup>th</sup> FAI World Cup & 13<sup>th</sup> FAI European Championships in FS, 11<sup>th</sup> FAI World Cup & 10<sup>th</sup> FAI European Championships in Arts, 2<sup>nd</sup> FAI World Cup in Speed Skydiving, 8-12 Sept, Teuge, Netherlands**

At this time the delegation comprised of Phoenix and 4mula (both FS 4-way Open) Paul Bantock, Jason Bird, Mike Lovemore and Max Hurd (Speed), Freefly Euphoria (Freefly) and Euphoria Freestyle (Freestyle). Further invitations were to be sent to Brit Chicks (FS 8-way) and Eclipse (FS 4-way Open).

The potential eligibility of other 4-way Open FS teams was discussed (including DWS, Antimatter and Raykipo (flying as ACM)) however it was agreed as four eligible teams had accepted their invitations, it would not be possible to facilitate a further entry.

[Secretary's note: Brit Chicks had since declined and the invitation extended to Awkward Turtles, who had accepted. Eclipse (FS 4-way Open) had also accepted]

**31.4 Team uniforms for International Meets**

The Committee Secretary reiterated that this would be the last year she would be ordering and distributing delegation uniform. Jason Kelleher made the Secretary aware that he knew of a designer with links to clothing embroiderers. The Secretary stated that there was enough

stock to cover the delegations for this year and that an offer of design and assistance for next year would be of great benefit. Jason Kelleher would facilitate correspondence with the designer.

**31.5 1<sup>st</sup> FAI World Indoor Skydiving Championships, Prague, Czech Rep, 21-24 Oct 2015**

**31.5.1 Team Selection**

Based on the results at the Bodyflight World Challenge 2015 invitations would be sent to:

FS 4-way: Co-Motion then to Vision99 if Co-Motion decline

FS 4-way Women: Fly Like a Girl – Claire Scott had expressed the teams interest to attend by email

D2W (2 slots available): Josh O'Donogue and team Floh Well – Luke Warren had expressed interest to attend via email

Freestyle – Dave Reader had expressed interest. However it was reported that he would now compete for Norway.

As VFS 4-way was not included in the Bodyflight World Challenge Adam Mattacola would discuss attendance with teams QFX and Omni.

Adam Mattacola would provide the Committee Secretary with the team members for invitation.

**Action: Adam Mattacola and Committee Secretary**

[Secretary's note: After receiving further information it was agreed that Voodoo, who were looking to replace a team member, be invited to represent GB in FS 4-way. Josh O'Donogue had declined the invitation]

**30.5.2 Head of Delegation**

Jason Kelleher proposed that Kate Charters act as Head of Delegation. Seconded by Adam Mattacola.

**Carried unanimously**

**31.6 2015 World Air Games, 1-12 Dec, Dubai**

**31.6.1 Team Selection**

Jason Kelleher acknowledged that the minute regarding NFTO from the previous meeting had had been based on information available at the time. The team are eligible under the 50% change criteria (as Kaizen) and could accordingly be issued with an invitation. Jason Kelleher proposed the NFTO represent Great Britain in FS 4-way Women. Seconded by Mike Lewis.

**Carried unanimously**

Mike Lewis proposed, based on new information that it was the country not the team to be invited; and that the dates were now staggered allowing the team to organise time off from work, that Microclim8 represent Great Britain in FS 8-way. Seconded by Adam Mattacola.

**Carried unanimously**

VFS was now included and selection would be based on the 2014 Nationals.

[Secretary's note: During writing the minutes the Secretary made the Committee aware of an email she had missed including in the Council post before the meeting, sent by the Artistcs & VFS Discipline Rep to inform the Committee that QFX were eligible, as they had competed and placed highest at the 2014 Nationals, and of their acceptance to an invitation to represent GB in VFS 4-way]

**31.6.2 Different dates for disciplines CP, FS & Arts**

It was reported that the CP would take place over 2-7 December and the other disciplines on 6-11 December. It had not yet been clarified as to the timings of the Opening and Closing ceremonies, and to the medal presentations. The Committee would await further news from FAI.

**32/15 Competitions Budget 2014/2015 and Action Plan 1 July 2014 – 30 June 2015**

Weed Stoodley, who was not at the meeting, had circulated a budget statement to the Committee before the meeting. The Committee noted an overspend of the allocated funds for the Judges budget however all other targets were well within budget.

**33/15 Skills Coaching Roadshows**

The Committee acknowledged Weed's email report of the VFS/Artistcs Roadshow which been well attended and had had good weather. Verbal reports were received from Jason Kelleher, that included a roadshow by team 4mula at Black Knights, who had been

appreciative of the assistance from some members of team Phoenix, and from Gavin McLeod where 1 roadshow at Hibaldstow had been blown out but the coaches were able to cover safety briefs, and another at BPS Langar that despite bad weather on the 1<sup>st</sup> day, had been attended by 7 of mixed ability with one attendee gaining a CF1 and another receiving a Coaches rating.

**34/15 Judging Matters not already covered**

The Judges Coordinator reported that BPA judges received a lot of requests to judge at overseas competitions and that their hard work was being recognised. The Committee echoed her pride in the BPA judging team.

**34.1 Up & Coming Cameraperson Award criteria**

The Committee Secretary asked of the criteria's availability as to be included in the Committee Handbook. The Judges Coordinator replied that as the Judges would have new laptops each judge would be able to highlight any new camerapersons work. The Judges were working together to provide workable criteria that would be presented at the next Committee meeting.

**35/15 Any other business**

**35.1 BPA policy of use and embroidered badges**

This was to be discussed at the Communications Committee meeting however the Committee Secretary asked the Committee if they had any comments as she believed the wording of the policy at this time was ambiguous. The consensus of the meeting was that those who had not competed at international level for 2 years would not be considered for replacements.

**35.2 National token gift**

Following on from the previous item the Judges Coordinator suggested that at some International meets other delegations gave tokens of their NGB or similar, and that the BPA may wish to consider to do the same. As the meeting had overrun it was asked that this be considered at the next meeting.

**Agenda, next meeting**

**35.3 2016 World Parachuting Mondial, 9-22 Sep, Chicago**

Carl Williams, as winner of the BPA Open National in Accuracy 2015 had expressed a team's interest to attend, which included Carl, Pete Sizer, Nicky Johnson, Janos Leszko and Steve Hastings. The Committee agreed that they would be eligible. John Smyth reported that accommodation was already being booked and volunteered to source and block book 50 rooms.

**Action: John Smyth**

**35.4 Funding Criteria document – 1<sup>st</sup> draft**

Mike Lewis spoke to his document which had been circulated to the Committee via email and reported that it was to make it clearer to the competitor which category they would fall in. As was the 1<sup>st</sup> draft he asked the Committee to read the document and provide feedback.

**Action: Competitions Committee**

**35.5 Member communication regarding funding**

The Committee noted the email, circulated with the agenda, from Stubert Ferglstein regarding coaching funding and that his team had been refused coaching funding on the basis that they had not met the criteria of a 75% team change which was then confounded by the criteria reported in the e-newsletter dated May 2015 of 50%. The Committee acknowledged that the criterion as reported in the e-newsletter, was incorrect, for which the Committee could only apologize. As 2 team members, inclusive of the cameraperson, had stood down the Committee agreed that the team would not be eligible for coaching funding and could only apologize for the reported error. Mike Lewis asked that a memo be sent to all Discipline Reps to consider a team percentage change for each discipline to be included in the funding criteria document.

**35.6 NFTO – Coaching funding**

The FS Discipline Rep stated that he has received an email from NFTO enquiring of coaching funding for teams at the top of their game. The Committee responded that off-year coaching was only available for non-senior teams who were looking to compete at a higher level.
